AMENDED STIPULATION AND ORDER ESTABLISHING PROCEDURES FOR THE REVIEW OF ASSERTED LIENS AGAINST SETTLING IMPLANT CLAIMANTS

Pursuant to § 7.02(a)(iii) of the Settlement Facility and Fund Distribution Agreement ("SFA"), the Finance Committee has the authority to "seek orders from the District Court... establishing procedures for distributing payments involving liens or disputed payees." The Finance Committee, Debtor's Representatives, and Claimants' Advisory Committee have presented to the Court this agreed Amended Stipulation and Order that adopts the "Procedures for the Review of Asserted Lien Claims Against Settling Implant Claimants." The Amended Stipulation and Order was entered by the Court on June 5, 2005. The parties have revised various provisions and the Proof of Lien form (Exhibit 1 to this Order).

The Court retains jurisdiction over the assets of the SF-DCT and has authority to resolve controversies and disputes regarding interpretation of the Amended Joint Plan of Reorganization and Plan Documents. See Amended Joint Plan§ 8.7.3 See a/so SFA §§ 4.01 and 10.09.

After consideration of the agreement of the Finance Committee, Debtor's Representatives and Claimants' Advisory Committee,

IT IS ORDERED that the Revised Procedures for the Review of Asserted Lien Claims Against Settling Implant Claimants attached as Exhibit 1 hereto are hereby approved.

IT IS FURTHER ORDERED that these Procedures modify and supersede the Court's prior Order dated February 18, 2005 and June 5, 2005 and these Procedures shall control.

IT IS FURTHER ORDERED that the fact that the Lien Judge has a current or prior association with the SF-DCT or the Finance Committee shall not be considered a conflict and shall not be an impediment to the Lien Judge's service.
